- 1. The National Yunlin University of Science and Technology (hereinafter referred to as the school) has formulated this specification for the purpose of handling the admissions assignments for each academic system.
- 2. The school shall handle the admissions examinations for each academic system in accordance with the principles of fairness, impartiality and openness.
- 3. There must be no racial discrimination in the admissions of each school system. If the Ministry of Education has regulations on bonus points and preferential treatment for specific ethnic groups or specific identities, it should be handled in accordance with the regulations of the Ministry of Education, such as increasing economic assistance to culturally disadvantaged and multicultural (such as Indigenous) students. measures (in combination with the review rubric), etc.
- 4. There shall be no gender discrimination in the admissions of each school system, and shall be subject to Article 13 of the Gender Equality Education Act, "School admissions and school permits shall not be discriminated against by gender, gender characteristics, gender identity or sexual orientation. However, based on historical traditions and specific educational goals Schools, classes, and courses established with the approval of the competent authority, or for other justifiable reasons other than gender factors, are not subject to this limitation."

- 6. Provide necessary assistance to candidates with disabilities when taking the exam.
- 7. Other matters not mentioned above shall be handled in accordance with the Ministry of Education's "Key Points for Examination of University Admissions Regulations".

8. This specification shall be implemented after being approved by the Admissions Committee of the school and submitted to the Executive Council for deliberation and approval, and the same shall apply to amendments.
